There were no baptisms or weddings this year.

Official Board

The Official Board of Robert McClure UC consists of the Chairs of various Committees, plus the Board Chair and Secretary, and the Church Treasurer. As Board Chair, my responsibilities are to prepare the agenda for each meeting, make sure we follow this agenda (to the best of our ability), and also make sure that each needed motion is passed appropriately. We meet on the fourth Tuesday of each month, except for July and December. Before the meeting, each member is asked to submit a SNAP (Summary of News And Progress) report to the secretary, who then distributes them to all members along with the Agenda for the meeting. By reading these before the meeting, we save time that can then be spent on other things, such as Check In, a Devotion and a Workshop.

When I did my report last year, I don't believe that I thought we would be in the same situation again this year. However, we are currently still having our Board meetings through Zoom, as are many of the other committees. There are some groups able to meet at the church, but only after receiving permission from the Board, and only in the sanctuary. Our Ad Hoc Re-opening Committee has been doing wonderful work at planning the arrangements necessary for everything to be safe when we do finally open all things up, especially our Worship Services. I do want to thank them all, and especially the Chair, Linda Bossler, for their hard work.

The various committees will give you the details of what they have been doing, and I want to thank all of the Chairs and members for keeping things going through these still trying times.

Although most of the Province's restrictions are being lifted, it doesn't mean that we will be having our regular services immediately. There are still many safety measures needed to be ready before that happens, but we will keep everyone up to date as to when the church will be ready for each event to happen.

In more positive news, our refugee sponsorship is now moving forward. You can read the details in the report, but please note that we still need to continue contributing to the Refugee Fund to help them.

I wish to thank the members of the Board for another good year. The Worship Committee has done a wonderful job with our online Sunday Services; Rev Kelly and other contributors have

enriched our thinking with their sermons and talks, and our Food Pantry volunteers and the Caring Committee have been working constantly to help those in need in our community. Everyone on the Board has continued their great work throughout the year, even with the restrictions still happening around us.

I hope everyone will continue praying for our church, and, whenever the time comes, meet together once again at Robert McClure.

Affirming Ministry Action Committee

After the last AGM, the committee members consisted of Darlene Thompson, Barb Lough, Darlene Montgomery, Louise Omania, Kelcie Perih and Linda Bossler. Ken Thompson took a sabbatical from the committee with the intent to rejoin when meetings resumed in-person.

Throughout this past year, the committee has focused on the work to develop the Inclusive Language Guidelines. Our goal was to develop guidelines that honour all the diversity named in our Affirming Faith Statement – "celebrating and acknowledging diversity in age, health, race, economic status, ethnicity, beliefs, culture, gender identity, sexual orientation." Our work has been informed by several resources that were identified and researched by committee members. The work to finalize the document involved joint meetings with the Worship Committee and presentations to the Board. I am delighted to announce that on November 23, 2021, the Official Board accepted and passed, as a living document, the Inclusive Language Guidelines for Robert McClure United Church. The full document can be viewed on the church website. I would like to thank the members of AMAC for all the dedicated time, energy and work that went into creating the guidelines. It was a "BIG" undertaking.

At the request of Rev. Kelly Osgood, the committee undertook to navigate all that was involved to include Robert McClure UC in the 211-information database. This is another way to let the wider community know about our affirming ministry, the food pantry, the community garden, etc. As we return to the building, more of our programs can be included.

The P.I.E (public, intentional, explicit) celebration in worship was held on March 14. AMAC and the Worship Committee worked hard to create a wonderful online worship service. Kelly Strain shared a very touching, personal testimony as part of the message that day. Louise Omania offered a very creative 'recipe' for Deep Dish Diversity PIE.

Working together with the Worship Committee, there was a celebration of Pride Sunday on June 6th. We had an opportunity to hear again a testimony from Sim Gilbert as part of the message – Intimately, Uniquely, Distinctly Created.

An opportunity to tune into the annual City-Wide Pride Service was offered to our congregation on September 5, 2021. The Rev. June Joplin was the guest preacher that day. June made international headlines last summer when she came out as a trans woman and was subsequently fired by her Baptist congregation in Mississauga. She currently serves as Associate Pastor of the Metropolitan Community Church of Toronto.

Through out the year there were new learnings and inspirations brought to the committee from members who attended 'Adding Sparkle to Your Rainbow' (webinar offered by Affirm United); Queer Virtue Lenten Series and Jumpstart Your Affirming Journey (both offered by Affirming Connections).

Board of Trustees

The Board of Trustees is a committee made up of six members of Robert McClure United Church and the minister, who are responsible for the ongoing well-being of the church property, building and capital assets within.

The trustees provide the opportunity for a sober second thought regarding certain decisions, proposals or suggestions from the Official Board and any external institution which might affect the property or assets of Robert McClure United Church.

The trustees are Rev. Kelly Osgood, Barbara Humphrey, Carolyn Stuber, Jack Lough, Wayne Wonnacott, Robert Bossler and Craig Wonnacott.

Here are the items we worked on this past year.

- In last year's report, the assessed property value was recorded as \$1.7M, this was incorrect, it should have been \$2.79 M. The assessed value for 2022 is \$2.910M.
- RMUC Insurance is to be renewed at \$2.0m since the Farmers Market is not likely to occur.
- The Pandemic Bridging Loan from The United Church of Canada has been extended to Dec 31, 2023 interest free
- An automatic door opener on the main entrance was installed by DeKlerk Electric in June; bathroom doors were not installed due to cost.
- Our waste removal contract was terminated with Waste Connections Canada, and new service with e360 began in July. This change in service will save the church \$400 per month (\$4800/yr). The new waste bin includes a lock to prevent unauthorized use.
- A concrete ramp was installed by contractors working for the Pineridge Apartments. There was some major work needing to be done on the Apartments' property which necessitated the removal of the chain link fence and the raspberry plants in the

- community garden. As repayment, once the work was completed and the fence replaced, they poured a new concrete ramp sidewalk at the East entrance of our building.
- As per the City of Calgary, RMUC is now responsible for an annual inspection of the fire hydrant at the south end of the property. This inspection was completed in May, at a cost of \$238.
- A security camera was installed near the front door. This was in response to an individual experiencing homelessness who was regularly sleeping in the front gardens. On some very cold nights this past winter, the individual also started fires beside one of the front pillars, causing some damage, and prompting the camera install. Since the camera was installed, the individual has not returned.

Individuals, small groups or committees may contact any trustee at any time if they have any items of concern regarding the property and/or the assets of Robert McClure United Church which they feel need to be investigated or discussed that would not normally be addressed by the Official board.

Caring Committee

The purpose of the Caring Committee is to provide care and connection with the McClure church family and friends.

There are subgroups under the Caring Committee umbrella, including Bridges of Love, Card Ministry, Food Pantry, Healing Heart, Healing Prayer Chair, Hospital Visiting Ministry, Prayer Chain, Prayer Shawl Ministry, Senior's Socials, and Telephone Ministry. All of these groups have something in common: their focus is outreach from the heart into the congregation and community.

Members of the Caring Committee Team include Shirley Skulmosky, Donna Pederson, Shirley Dufour, Garth Paynter, Marilyn Shingoose, Maureen Routley, Sharon Smith, and Barb Lough (Coordinator).

Bridges of Love

• In 2020 we became a part of the *Bridges of Love Society* which is a network of local churches that provides an alternate place of emergency preparedness when first responders are over-extended. This includes providing an emergency gathering place in times of disaster should the need arise.

Card Ministry

- In 2021, 14 cards were sent/provided, including get-well, sympathy and support. This compares to 29 cards in 2020. Gratitude was often expressed for being remembered in this way.
- If you know of someone needing this support, please contact the Coordinator.

Food Pantry

- Volunteers with the Food Pantry include Alan Barton, Mac Dingwall, Sandy Ert, , Randy Manson, Norm McDowell, Garth Paynter, Otto Sanchez, Wendy Smith, Verne Stuber, and Barb Lough (Coordinator).
- Ron MacRury, Lorna McKenzie, Joan Liland, Cynthia McTaggart and Pat Hlady also support the Food Pantry in various ways, but are not on-site on distribution day.
- We were saddened by the passing in September of long-time Food Pantry volunteer, Richard Taylor.
- The Food Pantry is open to clients on Thursdays from 11:30 am to 1:00 pm. Minister Kelly Osgood provides spiritual care to clients requesting this care during food distribution time.
- We receive donations of food from organizations such as Spinz Around, Leftovers, Cobs Bread in Marda Loop, No Frills in Temple, Country Lane Chicken, Chestermere Safeway, and bread from Costco.
- As well, many people support us with gifts of groceries, pasta, beans, canned fruits and vegetables, and plastic shopping bags, and much more, for which we are so grateful.
- In 2021 we received a grant from The United Church of Canada, through Chinook Winds Region, in the amount of \$3,000.00. The grant helps cover such expenses as the \$1,200 per year fee to Spinz Around; the weekly rental of a U-Haul van used to pick up food from Spinz; latex gloves, masks, sanitizers, bread bags, produce bags, etc to assist in the operation of the Food Pantry.
- NOTE: In 2021 this small Food Pantry, and its enthusiastic and hard-working volunteers, provided food to over 9,000 people, approximately the same number as in 2020. One third (3,131) were children and 1,236 were seniors. We sincerely believe we are experiencing God's grace in action, feeding hungry people.
- The 2021 Thanksgiving Gazebo Gifts and Christmas Eve Manger Gifts were so appreciated by our clients. The Food Pantry Coordinator and Volunteers sincerely thank you. Food Pantry clients were grateful to receive many items, including hats, scarves, mitts, gloves, personal care items, treats and goodies. Your generosity helped brighten the day for people depending on us for assistance.
- We were the lucky recipient of 75 stuffed animals from the Calgary Flames organization's *Hitmen Teddy Bear Toss*. Thanks to Armand Massey who originated this idea a couple of years ago, and to Ron MacRury and Mac Dingwall who went to the Saddledome to pick them up. Our littlest clients loved the gift of a bear, or a unicorn, or a zebra, or other sweet stuffie.

Healing Heart

• There is a group of volunteers trained in various healing energy modalities including healing touch, reiki, healing prayer, etc. We've been on a pandemic-enforced hiatus for a couple of years, but we anticipate a rejuvenated ministry as soon as we are allowed to be in each other's presence once again.

Healing Prayer Chair

- Prior to pandemic, we provided a healing prayer chair during communion. A script was written for the members doing the praying, just in case they got stuck for words.
- Anyone needing particular and confidential prayer was encouraged to sit in a chair at the
 back of the sanctuary once they had received communion. They would then be anointed
 with healing oil if they so chose, and prayer specific to their need would be invoked.
 Others wanting prayer were asked to maintain confidential distance until their turn in the
 chair.
- There was good response to this particular ministry, and we anticipate revitalizing it when we are able to be in the building once again.

Hospital Visitors

- Six Caring Committee members participated in a training program for hospital visitors, under Alberta Health Services. We were a pilot project for Chinook Winds Region of The United Church of Canada.
- Due to the pandemic, no hospital visiting is taking place beyond designated family members at this time.
- We wait to see how this ministry will happen once the pandemic restrictions end.

Prayer Chain

- Members of this ministry include Margot Aftergood, Maeve Bard, Karen de Carle, Barb Humphrey, Barb Lough, Jeanette MacDonald, Kelly Osgood, Heather Templeton and Donna Pederson (Coordinator).
- The Prayer Chain is a dedicated group of 'pray-ers', who pray regularly and faithfully, prayers of concern, gratitude and healing. The prayers include those shared at the online Sunday Worship Service, the online *Praying Through the Pandemic*, and requests that are made directly to Coordinator Donna Pederson, or others in the Prayer Chain Group.
- This group spends time every week, prayerfully and selflessly, sending God's love and energy, to so many individuals. During the course of the past year, we have seen increasing numbers of folks needing and requesting this support.
- It is important to note that any prayers that come through the committee members, (apart from those spoken at Sunday Candle Prayer Time) are kept in strictest confidence. We all recognize the importance of this ministry and the comfort and peace it brings, as is often communicated to us by those we pray for.

Prayer Shawl Ministry

Our prayer shawl group did not meet in 2021 because of the Covid situation, however we did give out 14 shawls to very deserving persons.

We were able to keep up to these requests due to the generous donations of a few persons who carried on knitting and turning in their shawls. A huge thank you to these ladies. This ministry is one of love and caring for persons who are in a difficult time in their lives and need a warm hug in the form of a handmade shawl. It also provides a meaningful way for those who wish to donate their time and talent.

Hopefully we will be able to return to gathering on Monday evenings to knit together and enjoy a time of fellowship as well.

Financial Report

Here are the financial highlights from 2021:

- 1) For the month of December we incurred a net surplus of \$1,950.69 compared to our budgeted surplus of \$7,739.60. We ended the year with a net deficit of \$(16,958.99) compared to our budget of zero. Offerings are \$(45,065) under budget, salaries are under by \$13,447 and the Canada Emergency Wage Subsidy exceeded budget by \$11,748.
- 2) At December 31, 2021 we had \$17,333.92 in the bank made up of \$27,341.32 in designated funds and \$(10,007.40) in operating funds 'overdraft'. We also had \$4,865.00 in grocery gift cards on hand. By comparison at December 31, 2020 we had \$35,813.42 in the bank made up of

\$26,515.44 in designated funds and \$9,297.98 in operating funds. Operating funds decreased by \$(19,305.38) in 2021.

3) We received \$18,748.17 from the Government of Canada in Emergency Wage Subsidy.

McClure Fellowship of Gardeners

We are one of only a few gardens in Calgary with no residency requirements – members simply provide their rental fee and ongoing volunteer hours working on common areas. The garden provides us with opportunities to connect with other gardeners and horticulturalists from our community and beyond. Check our Facebook page, click on story, for a brief history of the garden.

The 2021 season had its ups and downs:



- Covid -19 continued to determine how we could gather as a community of gardeners, however we managed meet our fellow gardeners in a safe manner.
- The fence along the north side of the garden was removed to allow the repair of the underground parking in the apartments. The gogi berries and raspberries had to be removed and dirt was piled on the beds along the fence. This meant a slow start for some gardeners who were unable to plant until after the first week of June. The contractor had promised to provide us raspberries to replace the ones that had to be moved; hopefully we will receive them this year. The gogi berries were moved to the northwest corner along the fence. Gardeners missed the berries, hoping we will have some to pick in 2023.

The Garden:

- We had 56 beds, this included the program beds rented by Trellis
- 2 round herb beds.
- 2 large beds that were used to grow potatoes, garlic, strawberries. A portion of one of the long beds rented by 2 gardeners.
- The orchard has Saskatoons, cherries, grapes, strawberries, apples, rhubarb and red currents; the fruit from the orchard was available to both garden and church members. There was a very poor harvest in 2021.

Activities:

- In person AGM was cancelled due to Covid restrictions. The AGM report and the financial report were shared on line.
- We had 27 gardeners, which included 4 new gardeners. Monthly work bees were cancelled, however we had great cooperation from gardeners the compost arrived.
- In all about 100 pounds of potatoes as well as beets, zucchini, onions and tomatoes were donated to the Food Pantry. Individual members also donated produce to the food pantry.
- Garlic was also planted in part of one of the long beds. The garlic harvest0f 2021 was a bit better than in 2020. Most of garlic was used for fall planting, with a small amount was sold.

- Hopefully we will be able to have an in person annual meeting in 2022
- Remove unproductive beds that are shaded by trees.

Refugee Report

The Aslam family Naeem and Fozia and their 3 children Anika (14 years old), Micayel (9 years old), and Anayil (8 years old) have met with the United Nations Refugee Agency for their refugee interviews and their medical assessments over the last few months. They were successful in their interview and passed their assessments. It is now just a matter of waiting for the government to inform them on when they can get their documentation and an idea of when they can fly out of Thailand.

A bit about the family:

Naeem, Fozia and their family are originally from Pakistan however, due to their Christian beliefs and their involvement with a young man who asked for assistance, they were forced out of Pakistan and fled to Thailand. They are unable to return to Pakistan as the family (a very affluent family) of the young man they assisted continues to threaten them with violence as well as jail. It was once they fled to Thailand that they began looking for sponsors to help them get to Canada.

Scarboro United Church has donated \$8000.00 for the family which will be put into a trust fund that can be used once they arrive in Calgary.

Many of you have donated money, clothing, household items and furniture. The family has asked that I share with you their appreciation for all that the church has done so far and they send blessings to us all.

Our next big need is housing which at this time is difficult to set up as we do not have a set date of arrival.

Re-Opening Ad Hoc Committee

The committee members include Andy Armstrong, Linda Bossler, Karen DeCarle, Barb Humphrey, Barb Lough, Kelly Osgood, Garth Paynter, and Isabelle Templeton.

The committee's work has resulted in a Re-opening Plan that has 4 phases and it is considered a living document. The implementation of each phase is determined by the Board. To date, the Board has approved Phase 1 (February 23, 2021) and Phase 2 (November 23, 2021).

Phase 1 includes all the protocols as outlined by AHS and the City of Calgary. These protocols are updated as necessary. Phase 1 also includes protocols for cleaning, sanitizing, and lines of communication specific to our church setting. In Phase 1, use of the building was limited to Office, Worship recording sessions, Food Pantry and Traveling Teacups. Committees and Small Group Ministries were asked to request approval from the Board to hold in-person meetings.

Phase 2 opened up possibilities for in-person meetings with the Church Administrator and the Minister. These are to be arranged ahead of time and based on the safety and comfort of those involved. This phase also gives the Worship Committee permission to determine when it would be safe to begin in-person worship services. Everything that is in Phase 1 applies to Phase 2.

The activation of Phases 3 and 4 are yet to be determined. Phase 3 allows for Rental Congregations and Outside Groups to use the building following the same protocols as outlined for RMUC. The protocols for Phase 4 will be developed in the New Year. This will cover what needs to be in place for WonderKids and Youth Group to resume their programs in-person.

Worship Committee

2021 continued to be a year of the Covid Pandemic. Every time we thought maybe we could worship in the church building the number of Covid cases, people in the hospital and intensive care continued to increase. It's been an unbelievable time which became our new kind of "normal".

We worshipped online Facebook Live. Here's some highlights:

- We celebrated Epiphany worship on January 3 "Arise, shine, for the Light of the World has come! Darkness covers the earth and its people, but the radiance of God's Light burns away its shadows, illuminates the smallest corner. Alleluia!"
- Also in January, while our minister Kelly Osgood was on continuing education our
 worship services were led by lay leaders. The first Sunday, the message was written by
 Barb Humphrey but thanks to Sam and Linda Bossler for leading the worship service on
 "Come and Follow Me". And the second Sunday was led by our Licensed Lay Leader,
 Barb Lough, with her message titled "God will Raise up a Prophet."
- Kelly Osgood preached on Stewardship Sunday, where she invited us to think about times when we are not a good steward. What are the behaviours of someone who does not take good care of God's creation and all the gifts given to us?
- February 14 was Mardi Gras. Thanks to Amanda Shaw and her wonderful talents with videographer we were able to hold our parade online. Kelly Osgood shared the meaning of Mardi Gras and reflections on mask wearing the masks we wear everyday because of the pandemic and the masks we wear for Mardi Gras.
- Ash Wednesday, the day after Shrove Tuesday, is the first day of the forty-day season of Lent. At RMUC we practice this ritual on Ashes Sunday which was on February 21. Kelly Osgood did an amazing job of marking a cross on a window frame so that we could all experience the ritual online. The ritual turns our heart, mind, and soul towards God. We remember that God created us from dust and to dust we will return.
- Our Lent series was where we contemplated the symbol of broken glass beach glass to be specific. Ordinary pieces of tableware or bottles tossed into the ocean. Year's pass, and then one day, there it is upon the shore: a small piece from one of those long-ago discarded objects. Shifting currents have rounded its edges; polished its surface. An ordinary fragment of glass that time and adversity have transformed into something beautiful.

Vessels, holy and whole Broken, needing the One Open, body and soul Healer, come.

This is the journey we took for Lent. Jesus healed and restored those considered broken.

- We celebrated P.I.E (public, intentional, explicit) Sunday on March 14. Affirming Ministry Action Committee (AMAC) and the Worship Committee worked together to create this online worship experience. Kelly Strain shared her personal testimony and Louise Omania shared her creative recipe for PIE.
- March 21 marked our 52nd online Covid worship service.
- Palm Sunday was on March 28 with a palm parade and drama called "Great Deeds of Power" with the characters: Matthew, the tax collector – Gord Humphrey; Simone, the fisherwoman – Amanda Shaw; Jamie daughter of Zebedee – Laura Strain; Thomas – Rob Bossler; and Narrator – Kelly Osgood. - April 2 was Good Friday. Thanks to Kelly Strain, Isabelle Templeton, Heather Templeton, BethAnn Friesen, Andy Armstrong, Connie MacRury, Karen DeCarle, Amanda Thompson, Jack Lough, Sim Gilbert, Barb Humphrey, and Sam Bossler for reading scripture. We shared in an anointing of oil for Extravagant Love where we thought of the people whose extravagant love had been poured out upon us, offering us care.
- On Holy Saturday we gathered at the church outside (following all covid protocols) for "Journey to the Cross" with different stations to stop at to reflect on the life of Jesus ending at the empty cross in the gazebo. We held a "Waiting for a Miracle Lights Campaign" which was a new beginning in Christ love for the Easter season. Lights were illuminated at the gazebo and loved ones and prayers were shining bright.
- Easter Sunday was a worship service with communion, Alleluia's, butterflies, joy, and Christ is Risen Indeed.
- Kelly Osgood preached a series during the Easter Season (which is the season from the Sunday after Easter Sunday all the way to Pentecost Sunday), on exploring how Jesus reconciles and makes new through the cross and the resurrection.
- Earth Day was held on Sunday April 25. This service was planned by the worship committee and the message was shared by Barb Humphrey called "God's Beautiful World and Creation"
- On May 9 our worship celebrated Mother's Day and Christian Family and the focus was on all people who provide mothering, nurturing, empowerment, and challenges.
- May 23 marked Pentecost Sunday where we celebrated the Holy Spirit who lives in us.
- On May 30, Barb Lough led worship where we learned about "The Trinity? What is it?"
- The first Sunday of June is the United Church of Canada Pride Sunday where we celebrate the lives and ministry of LGBTQIA+ and Two Spirit people in all their diversity. Sim Gilbert shared his testimony.
- June 20 worship focus was on Father's Day & Indigenous Day of Prayer planned by Barb Lough, Linda Bossler, BethAnn Friesen and the worship committee. We were honoured that Shirley Shingoose Dufour shared her story on reconciliation and being a residential school survivor.
- That brings us to the summer months where Rev. Kelly Osgood preached on messages called "Peter and John Before the Council," "The Apostles Meet Opposition," "The Story of Stephen," "Preaching Good News," and "The conversion of Saul."
- While Kelly Osgood was on vacation, we embarked on a journey during a worship series called "Travel as a Spiritual Act Life is a Journey not a Destination." It is a journey about traveling as a spiritual act. The first Sunday worship was led by Sam and Linda Bossler. Sam's message was "Leaving Home." The second Sunday in the series was led by Barb Lough with a message called "The Encounter." The third and fourth Sundays were led by Barb Humphrey with messages called "The Reflection" and "Coming Home."
- For the September long weekend, we invited people to join in worship with the annual City-Wide Pride Service which was presented by Calgary's Affirming Network of Faith Communities and Affirming Connections. The Rev. June Joplin was the guest preacher.
- September is the start of beginnings like the start of the church year, school and activities commence, committee meetings, and small groups gather. Kelly Osgood told a story

- called "No more Miracles" by Marc Gellman and many thought-provoking messages such as "The Desert Complaint Committee"
- October Kelly Osgood shared a pet blessing where we thank God for the animals in our lives and for the sacred spaces we have been blessed to be stewards of. A blessing for these creatures and this creation. This was in honour of Saint Francis of Assisi.
- Thanksgiving weekend we gathered at the church outside (following all covid protocols) for a Walk in "Thanks-Giving" to appreciate God's gifts and express thanks for God's world and creation. The walk was based on the United Church of Canada "The New Creed" and we must say thanks to Kelly Osgood for her photography talent. Each line of the creed had one of her photos to compliment the words.

- Thanksgiving Sunday's message was focused on being grateful.
- October 31 not only is Halloween, but it also marks All Saints Day where we lifted up the Saints of old, modern saints, and the Saints among us, for through the Holy Spirit, we are all part of the eternal, the divine, the Holy Imitating Christ.
- November 7 was a Sunday of Remembering. Jack Lough read "In Flanders Field" accompanied by Amanda Shaw's video of honouring Remembrance Day. Words were shared by Donna Pederson and Sharon Smith from WW2 and Afghanistan Veterans. Reading of the names and candle lighting to Remember was done by Barb Lough. The service included Act of Remembrance, Commitment to Remember, and Laying of the Wreaths.
- Advent begins with the first Sunday of Advent and the lighting of the Hope candle by Jeanette McDonald and Delores Massey. The second Sunday of Advent is the candle of Peace which was lit by Mac and Karen Dingwall. The third Sunday of Advent is the candle of Joy which was lit by Shirley & Alli Skulmoski. And the fourth Sunday of Advent is the candle of Love which was lit by Carolyn & Verne Stuber. Kelly Osgood's messages for Advent were "Invited to the New Kingdom," "Invited to Repentance," "What Do You Call Mary?"
- The virtual Christmas Pageant was recorded on Zoom and of course then Amanda Shaw took all the recordings and produced a production called "Sharing the Good News" which was a televised newscast immediately following the birth of Jesus. It was a light-hearted, contemporary take on the Nativity story. The players were Kelly Osgood as Michelle Handler (the on-scene reporter), Bev Hafeli as Bev Angel, Kacee and Merek Thompson as Kacee and Merek Angel, Gord Humphrey as Gord Shepherd (the surfer dude), Molly, Ashley and Grace Pentony as the shepherds, Cindy Davis as Lisa Lamb, and Alexi Gelinas as Alexi Lamb. Sam Bossler made a special appearance as "The King." The news anchor, better known as the Truth Checker, who seemed to know the actual details and offered small corrections was our own Barb Lough. - That brings us to Christmas Eve. Oh, the weather was cold outside, so we held our "Journey to Bethlehem" inside the church building. Registration was required and all covid protocols were followed. It was breath-taking with the luminary bags lining the

pathway. As you journeyed there were stations set up with a story candle, lantern and scripture that told the Christmas Story. The last station was the nativity with Mary, Joseph, and baby Jesus. Thank you for all manger gifts that we received for the Food Pantry.

- Part of the Christmas Eve journey was a fundraiser called the "Heart Connections Christmas Tree Share the Light" where you could buy a Christmas light bulb in honour of someone. Ribbons with their names were tied onto the strings of lights. The lights lit up the Christmas tree in the sanctuary. The sight was spectacular. Thanks to Bev Hafeli for organizing the fundraiser.
- We also held our traditional Christmas Eve Communion and Candlelight Worship Service online at 9:30 pm. The Christ Candle was lit by Linda and Sam Bossler.
- The Sunday after Christmas was Boxing Day, December 26 and it was a worship service of Scripture & Carols. The focus was the meaning of Boxing Day (using a resource from 'Advent Unwrapped' from the United Church of Canada).

Part of our worship planning was how could we help people feel more connected to worship. So, we created "take home worship bags." The bags were put outside the church front doors for people to pick up. Throughout the year we had Lent, Holy Week, Pentecost, Ordinary Time, Advent and Christmas Bags. They included items for the special services and for you to set-up your own worship centre at home.

Online worship does have its challenges. Technical issues from no sound, frozen screens, black screens, copyright issues, software issues, reboots all the way to funny faces. But we persevered and got through all the challenges even with some laughter and some tears too!

Thanks to Emily Osgood the WonderKids continued to meet on Zoom. They meet a couple times a month after church on zoom. The resources that we are using for WonderKids are from First Third Ministry of the Chinook Winds and Pacific Mountain Regional Councils of the United Church of Canada. They are called Faith@Home kits which empowers creative and engaging practices. These kits include practices, materials, activities, and craft supplies for the Liturgical Seasons of the Christian year.

We were very privileged to have Emily Osgood as our Artist in Residence for the summer through the Canada Summer Jobs grant program. She is very artistic and had many great ideas for her residence. Her projects included:

• Emily held a brain-storming session with congregational members to discuss the mural that she would paint on the door of the sea-can. It was discussed what Bible story best describes our congregation? What colours, shapes, and images come to mind when you think of the church? And what do you want the mural to communicate about the church to the neighbourhood? A decision was made that it would be a dove with the rainbow colours bursting out from the dove with the colours continuing onto the adjacent garbage container storage.

- Kelly Osgood challenged the congregation to read the Book of Acts during the summer and when completed they could choose a miniature painting of several different biblical images done by Emily.
- Emily painted Advent and Christmas images on acrylic to hang in the sanctuary windows.
- One project was to focus on the small groups of the church and put that into a wall mural.
- Painting on the plexiglass for the musicians
- Emily took a stained-glass course and made a stained glass hanging of the sunrise which is hanging in the window of the church.
- Emily taught the Parable in Art Workshops for All Ages there was no experience needed but just a desire to have fun, learn some techniques, share the parables of Jesus, and express your own creativity. Emily shared her leadership and creativity with us to paint the parables using watercolour paints.
- Emily painted 215 and Counting, 2021 which is remembrance of that on May 27, 2021, 215 unmarked graves of Indigenous children were found at a residential school site in Kamloops, BC, after which, hundreds more were discovered across Canada, and continue to be. In light of this discovery, memorials around the country were assembled with children's shoes, each pair representing a child lost to the residential school system. This painting is of one of these memorials, assembled in Vancouver, BC. Inspired by Orange Shirt Day, each shoe has a bit of orange in it. The painting will be hung in the narthex at Robert McClure United Church until all 94 of the Truth and Reconciliation Commission's calls to action are completed by the Canadian government.

The experiences and creativity that Emily provided for our congregation were part of our faith journeys. Watch this YouTube video https://youtu.be/LrwihfUWK_s to see some of Emily's masterpieces and her explanation of each project.

Amanda Shaw is our amazing videographer. We are so very grateful for her artistic, imaginative and talents. She's so talented and willing to try anything and the graphics and animation that she adds to the videos are amazing. This year she has been painting pictures to the scripture readings. They are breath-taking. We will be framing some of her artwork and watch for the fundraiser of a book "Scriptures through the Pandemic" including Amanda's paintings.

So many thanks to be extended – to our actors and narrators, scripture readers, worship planners, candle lighters, all the people that went out of their comfort zone and recorded themselves to be included in our online worship.

Thanks to Barb Lough and Linda and Sam Bossler for their leadership during worship and providing inspirational messages.

Thanks to the Worship Committee – Heather and Isabelle Templeton, Karen Dingwall, Andy Armstrong, BethAnn Friesen and Kelly Osgood for your support and imaginations and learning new ways to worship. Your dedication and worship planning are so appreciated.

Thanks to the musicians and especially the Quarantine Quartet – Sam Bossler, Jack Lough, BethAnn Friesen and Gord Humphrey. Not only are they the musicians but they are the worship set up people too. They help change the seasons of the church calendar from one recording to the next and sometimes even from one song to the next song. Seasons don't usually happen that quickly during real time but in recording time they do. Of course, these recordings can't happen without Amanda Shaw and Kelly Osgood.

Thanks to Barb & Jack Lough, Garth Paytner, Heather Templeton, Gord Humphrey, Linda and Sam Bossler for helping with the "Journey to the Cross," "Walk in Thanks-Giving," and "Journey to Bethlehem." The Worship Committee and our friends come up with these ideas (sometimes out of this world kind of ideas!) and then it takes a group of people to make it all come together.

There isn't a thank you big enough to say to Devynne Wonnacott, our Church Administrator. She is the glue that keeps the church together. All I can say is thank you, thank you, thank you and many more thank yous. She is fantastic! A special thanks to her for helping put the "take home worship bags" together. And making sure that all the music we use is licensed for online worship.

And, of course, we must extend our gratitude and gratefulness to our minister, Kelly Osgood. With her help we all continue to live our vision – intentionally creating space where the Holy Spirit sets our hearts ablaze and bursts out.

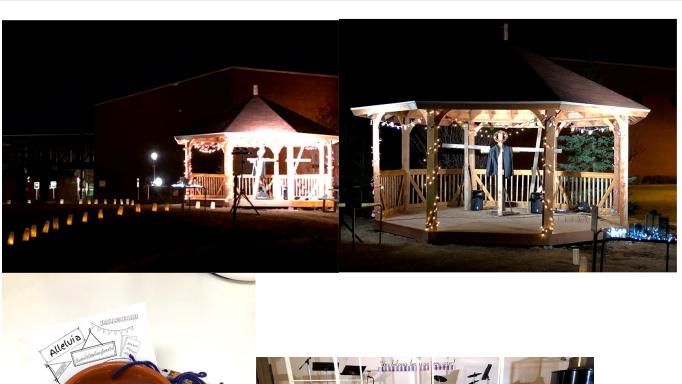

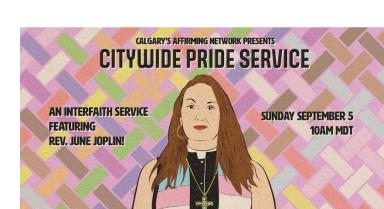








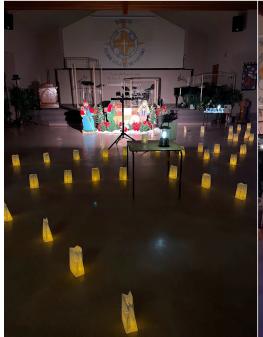
